Due to the continued high-level of interest in the **Voluntary Universal Life Insurance Program**, we are pleased to announce an open enrollment period. During this time, you will have the opportunity to increase your current universal life insurance policy or purchase insurance for certain family members with guarantee issue or limited underwriting. The insurance is issued by American General Life Insurance.

During this enrollment period, you can conveniently enroll by phone **1-800-463-7420**. The following options are available to you during the enrollment:

- Enroll by phone **1-800-463-7420**. (Please see reverse side)
- Enrollment is easy and **truly Guaranteed Issue** for employees employed for 30 days, actively at work and between the ages 18-60. Guarantee Issue means no medical questions.
- You may increase your current face amount of your current voluntary universal life insurance policy up to \$150,000 with no medical questions as well and apply for up to \$500,000 with medical questions.
- In addition to insurance for yourself, you may also purchase insurance for your spouse or domestic partner, dependent children, or dependent grandchildren who live with you with limited medical questions.

The **Voluntary Universal Life Insurance Program** offers:

- **Affordability** Minimum of \$3.00 weekly premiums required
- **Payroll Deduction** Premiums automatically deducted per pay period
- **Portability** You can take this same coverage with you when you terminate employment with the County and at the same premium.
- **Cash Value** Universal life insurance can build cash value over time through cash accumulation based on current or minimum guaranteed interest rates, provided premiums are continuously paid and subject to any applicable surrender charges.



Telephone enrollment meetings will last approximately 15 minutes. Please take the time to call a Benefit Specialist who will explain the program in detail and help you enroll in new coverage or make changes to your current coverage.
